 - The new bags will be provided to affected homeowners in the springtime.
 - Four damaged trees need to be removed, Carrie to request that these can occur next year.
 - \$16,000 allotted for next year's plantings current estimate is 22 new trees.

 - o RCW relates to resale certifications required by HOAs in Washington state.
 - Impact uncertain to GHOA.
